We understand that for Concert participation and to begin rehearsals we will be responsible for both the non-refundable Nutcracker Concert Fee (\$50 per household), and the non-refundable Costume Rental Fee (\$10 per costume) – both due Saturday, September 10th. We accept the inclusion of two Parent Passes with the Concert Fee, entitling our family to two general admission tickets for **two of the three** performances of the Concert Series, and tickets for the additional show and additional family members and friends are sold separately. _____ **(Please initial)**

We understand for Concert participation an adult representative from each family must agree to assist the school staff by signing the Performance Parent Helper Sign-Up Sheet posted in the studio office beginning Saturday, September 17th, through Saturday, November 19th. Sign-up is on a first-come, first-served basis, and families whom have not signed by November 19th will be assigned a position by the BR staff. _____ **(Please initial)**
